MARINADE close to pace, rallied going to 3/4, sustained the bid, drove clear under steady drive. GOTTA TEMPER no speed, launched a rally around the far turn, rallied widest in a blanket three way photo for place. DEAR SARA well placed, never far back, rallied, just missed place. BROTHER'S BLUFF outrun early, strong bid, could not sustain bid, blanket finish. APANASAN sent to lead, held advantage for 3/4, gave way. ZEBECCA reserved early, lacked late response. KATE'S LAW raced evenly with no response when needed. WESTERN WITCH failed to threaten. KENTA away quickly, flashed early speed, stopped. BEST REASON close to pace for a half, stopped.
