Footnotes

LORD CANELA quickly cleared to set all the pace, traveled along the inside throughout, increased margin in upper stretch and led firm under steady handling to the wire. MY NEWFOUND SAINT well placed racing a little off the rail stalking the pace, angled to the three to four path upper stretch, closed willingly picking up the place position in deep stretch. MCSUAVE rushed hard shortly after the start, moved into second place stalking the winner mid turn, loomed briefly in upper stretch, needed more late and tired coming to the wire saving the show position. TIMBER WILDCAT settled in the second flight, angled out for four wide mid stretch, showed belated interest improving placing but never menaced. CRESRAN broke well pressing the winner briefly, gave chase racing along the rail leaving the quarter pole, began to shorten stride inside the eighth pole. LAGOON raced evenly saving ground throughout, lacked needed punch despite being hard ridden in the lane. GOTASTORM lacked speed traveling towards the rear throughout, failed to respond to pressure never menacing. MILLENNIUM QUI tracked to the quarter pole, began to weaken from upper stretch. BULLYBULLYBULLY lacked speed racing mid track, showed little. HELL SPIKE was always outrun dull effort.
