Footnotes

TIGER STRIKE unhurried early advanced to threaten on the far turn, bid abreast RULER NEKIA down the lane in the two then three path gaining a share on the wire. RULER NEKIA sent clear set the pace posting soft splits through the far turn, digging in near the rail would battle late hitting the wire in tandem. JOHN JOHN'S GIFT veered out brushing the gate at the break, raced evenly off the pace angling to the four path in upper stretch, used steady response to best the others. MYBROTHERRON slow early saved ground to upper stretch improving a bit while no menace. ASCENDING SON gave a middle move to contention threatening through the far turn, wavered into upper stretch dropping off in the three path. CELTIC EXPRESS retreated on the backside. TEN MARTINIS stalked close up down the backside then wilted after a half mile.
