CRUISEN ALONG rushed into the far turn, dueled abreast rivals mid turn racing three wide, cleared leaving the quarter pole, was shortening stride in deep stretch, was under a drive to prevail being fully extended. JUSTIN A STORM hesitated and lunged at the break, was outrun to the quarter pole, swung out seven to eight wide top of the lane, was under a stiff drive from mid stretch, finished fastest of all to miss in a very hard effort. FALCON'S FOLLY was a step slow into stride and trailed at the quarter pole, hit stride in upper stretch, split foes at the eighth pole, surged strongly nearing the wire picking up third place in a good effort. THIN ICE tracked around the turn, bid four wide from upper stretch, loomed inside the furlong marker, was outgamed late vying for a minor award. SIERRA THUNDER settled in mid pack traveling three to four wide throughout, mounted a mild bid mid stretch, leveled off needing more late. VERONIE vied early racing between foes mid turn, battled to mid stretch, faded late. HELLO MARGO raced evenly along the inside, angled out top of the lane giving chase, weakened inside the eighth pole never menacing. SMACKY'S FAN well placed early running towards the inside, began to chase past the quarter pole, swung out six wide upper stretch while weakening. MY TRULY FAIR broke alertly and was angled to the rail, battled in a three way duel to the quarter pole, gave way mid stretch finishing spent.
