**Footnotes**

NEXT KITTEN unhurried early, saved ground throughout, angled off the rail taking aim on JULES CAESAR at the sixteenth pole, surged going clear at the wire. JULES CAESAR broke a bit outward, quickly rushed taking command, opened up entering the stretch, appeared to have a safe lead in mid stretch but was overpowered by a fast finishing NEXT KITTEN in last jumps missing in a good effort. LAWTONCIRCLE stalked along the inside to top of the lane, angled out three wide giving chase upper stretch, finished willingly needing just a bit more. SHOW ME THE CASH stalked around the turn running between foes, began to tire in upper stretch, no late threat besting rest. JUSTIFIER settled in the second flight racing well off the rail, mildly improved placing in the lane but never menaced. BOY G. raced abreast foes chasing the runner up around the bend, lacked late kick and weakened from upper stretch. BUBBALEWSKI lacked speed, saved ground throughout, varied little never factoring. SKIP THE TRIAL reared at the break spotting the field several lengths, raced wide offering little. BACKBACKBACKGONE tracked to the quarter pole, gave way in upper stretch, was vanned off after the finish.
