EYES A THUNDER sent clear was rated on pace through the backside, hooked from the outside by HOOCHED EXPRESS on the far turn would find more clearing in upper stretch then holding gamely late. HOOCHED EXPRESS sat close up stalking EYES A THUNDER through the backside, surged to even terms on the far turn then ceded a clear lead to the very game pacesetter in upper stretch, gave more late pressing the winner hard in the closing yards. SOCA TEMPO rated off the pace was asked for bid on the far turn, had limited response posing no menace to the top pair. SAINT BAYOU GOLD settled early gave a prompted middle move, dropped off the leaders on the far turn going evenly the rest of the way. BROTHER RON played no factor. SULTRY PLEASURE moved evenly through the far turn then flattened out in upper stretch.
