Footnotes

DAKOTA FREEWAY was patiently handled going down the backside, made a quick bid splitting foes mid turn, collared SUSANNE'S HONOR in upper stretch, slowly edged away under steady handling coming to the wire. SUSANNE'S HONOR rushed up along the rail shortly after the start, battled in a four way duel to the quarter pole, held a slim lead turning for home, fought hard once headed by the winner, yielded stubbornly proving a game second best. DUBAI CITY was outrun to the quarter pole, angled under a drive entering the lane, hit stride too late finishing with interest. FIDDLERS PRIDE settled early, rushed a six wide move mid turn, vied abreast rivals at the quarter pole, began to tire in upper stretch, bested rest. ANDY O rated and raced in the second flight, came six wide under left handed stick for the drive, showed late action but was no real threat. PREMIER COURT pressed then vied for the lead running three wide and between foes midway on the bend, started to weaken in upper stretch, no late factor. OCEAN OF DREAMS raced up close going down the backside, rushed a five wide move on the turn almost drawing even for the lead at the quarter pole, could not keep pace in upper stretch, weakened in the drive. RIGHT ON was a step slow into stride, raced wide being outrun. TIME CRAFTER broke alertly and held a head lead soon after the start, was pressured from both sides going around the turn, had enough and gave way entering the stretch, stopped and was eased inside the eighth pole, vanned off.
