Footnotes

LEGAL HEAT broke alertly and set the pace racing along the inside, headed by AT HEAVENS DOOR mid stretch, dug in under severe pressure to prevail in a very determined effort. AT HEAVENS DOOR stalked to mid turn, moved up three wide top of the lane, drew even with the winner in mid stretch, went head to head to the finish but was outgamed in last jumps missing in a hard effort. ABERNATHY settled in the second flight running towards the inside around the bend, angled out to the four path mid stretch, surged nearing the wire to miss and settled for third best. SCARLET BALL stalked along the rail throughout, put to a stiff drive entering the stretch, lacked rally and tired late besting rest. SPERANZA tracked the pace traveling four wide around the turn, failed to respond when asked for more. ABOVE GRADE was put to left handed stick shortly after the start but failed to respond, saved ground around the turn, never threatened. MIAMI'S SECRET lacked speed racing at mid track, came four wide into the lane, offered little. MARILYN'S STAR pressed the winner to the quarter pole traveling three wide, had nothing left by upper stretch, faded to the wire. GOLDEN FLATTER was quickly outrun in a poor performance.
