VALID CLEARANCE off slowly, began to move into 2nd turn, surged to lead, driving. DEWON AND ONLY sent inside, angled out to take lead, clear turn, overpowered. ALL FOR ME dropped back, mild move to 1/2, vied lane, outbid others. SEQUINED FLAG went evenly, rallied last turn, vied to lane, hung. MEMOREE sent inside, chased pace, weakened in drive. WHOWANTSTOKNOW dropped back, never involved. SING JUBILEE unhurried, swung wide, never fired. PRIME COMMANDER evenly early, rushed move backside, chased turn, wore out. FOURCARROTDIAMOND pressed pace, tired. BUBBLY BROOKE sent hard, overtaken backside, wilted.
