**Footnotes**

DIXIE RUCKUS rushed soon after the start and vied for the lead running three wide and between foes, dueled outside of TOO MANY WHYZ from mid turn to the eighth pole, drew clear late under steady handling. TOO MANY WHYZ rushed going into the far turn and angled to the rail squeezing KID KLARE, continued on dueling with DIXIE RUCKUS to mid stretch, yielded but gamely held on saving second place. WICKED ATTRACTION raced up close from the start, loomed on the bend traveling four wide, began to chase entering the stretch under a stiff drive but flattened out saving the show position. KID KLARE raced up close running along the rail, was squeezed and took up entering the far turn when TOO MANY WHYZ angled to the rail, settled towards the rear, tried to re-rally angling four wide upper stretch, lacked needed surge besting. MUTAKDDIM'S APPEAL was off slowly and outrun soon after the start, traveled three wide entering the stretch, never factored. IMAGATORURAGATOR flashed good early foot and vied briefly for the lead, soon retreated mid turn finishing weary. A STEWARDS INQUIRY WAS FOLLOWED BY A CLAIM OF FOUL FROM THE RIDER OF KID KLARE AGAINST THE RIDER OF TOO MANY WHYZ FOR INTERFERENCE ENTERING THE FAR TURN, AFTER REVIEW THIS CLAIM WAS UPHOLD AND TOO MANY WHYZ WAS DISQUALIFIED AND PLACED FOURTH.
