**Footnotes**

KID KLARE was in tight shortly after the start brushing with several rivals, stalked along the inside to mid turn, moved out four wide at the quarter pole, closed in on WICKLIFFE MAN under strong left handed stick from mid stretch, surged clear late. SOUTHERN SAIL was squeezed and taken up briefly shortly after the start, settled in mid pack, advanced splitting foes at the quarter pole, traveled towards the inside top of the lane, angled late surging between foes coming to the wire, made a late burst to get the nod for second place in a game effort. SILVER PIONEER was brushed lightly in a chain reaction shortly after the start, vied abreast foes mid turn running three to four wide, cleared at the quarter pole, angled inside top of the stretch, was outfinished in deep stretch and lost a head bob fighting for second place. GIN CITY bobbed at the break and bumped with SOUTHERN SAIL, rushed up to vie for the early lead, threatened to the quarter pole, began to weaken mid stretch, no late factor while besting rest. SENOR CAFE lacked speed and raced mid track, swung six wide under a stiff drive entering the stretch, failed to menace. WICKLIFFE MAN was brushed in a chain reaction shortly after the start, gave a brief chase racing mid track to the quarter pole, tired in the drive. CITY STRIKE veered out sharply herding rivals shortly after the start, dueled to mid turn, dropped off top of the stretch finishing spent. LIL GREAT TOUCH was bumped early racing between foes, outrun racing wide, never factored. DARLENE'S DEJAVU was always outrun, showed little. A STEWARDS INQUIRY CONCERNING THE START RESULTED IN NO CHANGE TO THE ORDER OF FINISH.
