SAND SABA went well placed stalking a hurried TAHOE JOE through the backside then rallying to even terms near the quarter pole, shook clear into upper stretch maintaining the lead the final eighth under a hand ride. RAYWICK dropped back early varying little to the far turn, circled wide into upper stretch surging abreast TRIPTANIC late to grab place. TRIPTANIC away slowly lost ground advancing into the far turn, continued on near mid track vying willingly under a stiff drive. ZIM AND TORRE rated off along the inside, roused leaving the backside with minimal improvement, continued to save ground into upper stretch lacking a late response near the rail. TAHOE JOE hustled out to the early lead, worked on honest splits through the far turn giving way to pressure in upper stretch. FREE CLEARANCE hustled along stayed close through the far turn flattening out into upper stretch. LADY'S EVENT had brief foot retreating on the backside. COURT APPROVAL stumbled from the gate was rushed hard for a half mile giving way on the far turn.
