BOBS TIEBREAKER rushed to the front, set all the pace traveling along the inside, drew off under mild encouragement from mid stretch, won easily being ridden out. CHALLENGER hustled down the backside, chased the winner from the quarter pole, failed to threaten in the lane then held place late under a drive. EVAN'S EMERALD was slow into stride and raced wide down the backside, continued to run well off the rail, rallied strongly from top of the lane, surged nearing the wire to miss second place in a game effort. WOOD ALLEY lacked speed trailing around the turn, put to a stiff drive entering the stretch, found best stride too late missing a minor award. BURN ONE TURN ONE well placed stalking early on, chased coming four wide entering the stretch, lacked rally never menacing in the drive. TAKE AIM sent hard dueling with the winner to mid turn, could not keep pace leaving the quarter pole, faded from mid stretch. SPIRIT TO RUN settled in mid pack racing off the rail, urged mid turn, failed to respond and tired in the stretch. ROSESANDASONG lacked speed, raced very wide losing ground entering the stretch, never factored. THREEWISEMEN steadily faded from mid turn, raced eight wide upper stretch, offered little. WOOD ALLEY WAS DISQUALIFIED AND PLACED LAST DUE TO AN INELIGIBILITY RULING BY THE BOARD OF STEWARDS.
