Footnotes

THE ALCOVA KID raced up close under a snug hold from the start, moved out entering the backside looming off a pair of duelers, bid three wide vying for the lead going into the far turn, dueled abreast to the quarter pole, drove clear top of the lane, increased margin under steady encouragement. HIGH SIGN raced along the rail for six furlongs, angled middle of the backside, bid four wide chasing the winner entering the stretch, failed to gain late and dead heated for second place. PLEASANT COMPANY stalked throughout while saving ground, rallied into the lane looming off the winner, needed more late and dead heated for second place. GREEN BOY unhurried early racing well off the pace, hit stride with a quarter to go, swung five wide upper stretch, finished strongly. TRES COPAS settled in mid pack, traveled mid track throughout, hard ridden on the bend, failed to menace. ROCKSIDE ROAD dropped off to trail shortly after the start, lagged to midway on the final turn, swung seven wide under a stiff drive top of the stretch, gave belated action but was no real threat. SPRING HONOUR set a rated pace running along the rail, pressured after a half, fought to the mile marker, gave way in the stretch. ROAD NOT TRAVELED unhurried and angled to the rail leaving the gate, never factored. EMPIRE BILL vied early on racing two wide, gave way after a mile, used up. GROOVY KID gave way early, no factor.
