TAPTOWNE pressed WHATTHECATDRUGIN from the start traveling in the two path, raced abreast at the quarter pole and inched clear, angled to the rail crowding that rival causing the rider to check hard at the three sixteenths, moved clear in mid stretch, was kept to task holding safe to the finish. WHATTHECATDRUGIN broke alert gaining control entering the first turn, set a pressured pace along the rail, headed by TAPTOWNE mid turn, ceded a narrow lead to that rival turning for home, had to check and stumbled briefly off the heels of that rival at the three sixteenths, came again cutting into the winners margin in deep stretch to finish a very game second. MORDI'S MIRACLE settled in good tracking position down the backside running in the three path, set down mid turn, rallied top of the lane, chased the top pair throughout the stretch drive but failed to make any headway settling for the show position. SON OF A GENERAL was off a step slow and was quickly outrun, lagged behind to top of the lane, passed one weary rival in the lane but never factored. EIGHTTOFASTTOCATCH well placed stalking top pair down the backside traveling in the two path, put to a drive mid turn, lacked response and gave way at the quarter pole finishing spent. A STEWARDS INQUIRY CONCERNING THE RUN ENTERING THE STRETCH RESULTED IN NO CHANGE TO THE ORDER OF FINISH.
