CONCORD POINT broke alertly to the early lead setting the pace two and three wide to the far turn, held EXHI at bay racing inside that one to upper stretch, kept to pressure late responded gamely. EXHI veered in crowding rivals at the break, moved off CONCORD POINT angling abreast the pacesetter on the backside, kept up the pressure into upper stretch giving all in the four path to no avail. NACHO FRIEND angled out on the backside tracking the pace from the five path to the far turn, made no headway there losing ground to the top pair in upper stretch while holding the others safe at mid track. SKIPSHOT in close at the break stayed back to the quarter pole, circled out six wide into upper stretch going evenly the final eighth. THISKYHASNOLIMIT unhurried early was roused to contention three wide on the far turn, failed to sustain the bid leveling off in the four path down the stretch. NOT ABROAD was squeezed by EXHI steadying at the break, struggled from the back to the far turn angling four wide into upper stretch with little improvement. TOH'S GREY CAT raced evenly off the pace through the backside then dropped back along the inside on the far turn. SHOOKSTOWN ROAD saving ground was always outrun. GUNFIGHTER stalked the pace racing five deep to the half then weakened on the far turn giving way to upper stretch.
