**Footnotes**

CASTLETON PARK stalked early pressing to wrest the lead on the turn, widened into upper stretch drawing out in the four path. NO FEAR HEAR pressed then chased through the turn, extending at mid track down the lane held on for place. PAUL BUNYAN slow early went evenly to upper stretch finding best stride late. MATTY'S ENFORCER chased the pace through the turn, all out in the three path the final eighth bid willingly. HARD TWO IMAGINE raced second flight, came six wide to upper stretch holding position late. MIRROR BALL slow early played no factor. STORM BY was never involved. BILLY GOES TO JAIL brushed at the break showed early speed then faded along the inside. NOBLE CAVALIER broke sharply to the early lead, ceded on the turn then wore down through the stretch. AWESOME BRADY was squeezed and steadied at the break.
