SEA DUBAI rushed to the front, angled in mid turn, widened upper stretch, won easily being ridden out. JUSTICE EXPRESS was in tight and brushed from both sides shortly after the start, rallied four wide entering the stretch, never threatened the winner but edged up late gaining second place in willing manner. ITSAFFIRMED stalked throughout, came three wide chasing the winner into the lane, never menaced and was edged out of second place nearing the wire. MARKET TUMBLE trailed early, beat a couple of weary foes while never factoring. CHAIRMANOFTHEBOARD raced evenly at mid track, weakened from upper stretch, offered little. SCOTCH TWIST flashed brief speed, began to fade leaving the quarter pole finishing well beaten. SEA DUBAI WAS DISQUALIFIED FROM FIRST TO UNPLACED FOR POSITIVE POST RACE TEST.
