**Footnotes**

MIRACLE IN MAY taken back early responded on the far turn bidding abreast rivals in the four path upper stretch surging by in the closing yards. ELLE CASHAREAU stalked the pace laying close up to the half, pressed in bid on the far turn dueling from the two path in upper stretch ceding to outside pressure late. VEILED VOW unhurried early advanced to threaten racing five deep on the far turn, dueling abreast ELLE CASHAREAU in upper stretch was joined on the outside by MIRACLE IN MAY coming up short between the pair. DEL BONITA away slowly trailed through the far turn, circled six wide in upper stretch gained late position. REMEMBERYOURPLACE raced evenly while saving ground, checked in close quarters near the eighth pole swinging out six wide in upper stretch finishing evenly. STORMY DREW prompted the pace through the backside extending on the far turn, would weaken abruptly in upper stretch. FILLAZZENNE prompted the pace to the half, would check in close quarters near the quarter pole giving way soon after. GUILTY TREASURES set the pace moving under pressure through the far turn, folded along the rail in upper stretch.
