FREEFOURINTERNET was outrun for the opening half, asked for more mid turn, gained momentum and swung 7 wide top of the lane, hit stride and caught leaders with less than 70 yards to go, inched clear under good handling. LA REINE'S TERMS was well rated while saving ground on the turn, rallied near the 1/4 pole, angled out top of the lane, dueled outside of STERLING GOLD throughout the stretch, cleared that rival late under a stiff drive but was overtaken in last stride in a very hard effort. STERLING GOLD stalked while 3 wide throughout, asked far turn, led, dueled towards the inside for the stretch run, proved no match late in a game effort. NINER'S ECHO showed good speed to press early racing between foes down the backstretch, could not match stride on the turn, weakened into the lane. HORRIBLE EVENING sent hard, set a pressured pace along the inside, battled to near the 1/4 pole, ceded grudgingly top of the lane, weakened in the stretch run. RAYMOND SPRINGS well placed early backside, tracked pace while 3-4 wide, was roused far turn, failed to rally and weakened from there. KASPAROV had no early speed, raced towards the inside throughout, was hard ridden on the turn, gave no response, no factor. FORGET THE JUDGE hustled to lay up close racing between foes to the half, asked for more but faded entering the stretch.
