EVAN'S EMERALD was hustled along pursuing through the turn, found stride clearing at mid track in upper stretch then pulled away late. MARCH TREND broke alert pressing the pace alongside KARAKORUMKONICHIWA through the turn, overpowered by MARCH TREND in upper stretch extended on the inside to save place. KARAKORUMKONICHIWA broke sharply pressuring the pace while racing off the inside through the turn, ceded in upper stretch going evenly the final sixteenth. OVERDRIVE laid close up giving urged pursuit through the turn, lacked surge down the lane hanging on the inside. DOWNONMAINSTREET slow early raced seven wide to upper stretch failing to respond there. JIMMY DA LAWYER was hustled while losing ground weakening into upper stretch. GLORIED was always outrun. CONCERTED ACTION reared up at the break laboring after. RAPID DEVELOPMENT dropped back on the turn.
