SOUTHERN OAKS hustled out followed the pace through the backside bidding clear on the far turn, dug in to pressure from both sides an eighth out in the three path holding up gamely. KEEN SOTO raced evenly to the far turn responding there rallying to contention abreast rivals in the four path an eighth out, bore down on leader late to no avail. ELITE ACCESS unhurried while saving ground cut the corner to contention in upper stretch, extended along the rail would go evenly late. POLITE COMPANY stalked the pace moving close up through the far turn, angled four wide in upper stretch gave even response to stiff urging. ADALINA LIGHT saved ground through the far turn angling to mid track in upper stretch, drew closer in the final yards. RESERVE A WIN lost ground racing seven wide in upper stretch finishing weary. BLAH BLAH BLAH sent clear set a modest pace through the backside, ceded the lead on the far turn giving way along the inside. CACUN CACUN raced off the inside chasing five wide through the far turn, faded six wide down the stretch. WANDA'S SECRET gave a prompted middle move then weakened on the far turn wilting to upper stretch.
