STORM WITNESS laid close up, tracked backside, extended turn, wore out. TOMMYSLEW raced mid pack, gained second turn, wilted. PALM CANYON well back early, no factor. MATCH ME NOW dropped back, labored. MISS ALLIANCE off slowly, offered little.
