**Footnotes**

GAMBOLIER sent hard, dueled inside of T CODE to the quarter pole, went clear turning for home, increased advantage under steady handling. T CODE sent hard, dueled with the winner to the quarter pole, ceded stubbornly mid stretch, held well for the place position. CORONA RIDGE raced evenly and towards the inside throughout, hard ridden leaving the quarter pole, improved placing but was no real threat. STIG'S DEPUTY rushed from the gate, raced up close and four wide on the bend, chased under urging entering the stretch, lacked late kick. PEAK TOPPER hustled along, was caught out five wide on the turn chasing the leaders, had no late response, bested rest. A P KNIGHT was in tight and bumped shortly after the start, raced towards the rear and off the rail, did mildly improve position but was no factor. SIX PANTS was off a step slow, lagged to the quarter pole, swung widest into the lane, found belated stride but was no factor. EXTRA PUSH brushed with A P KNIGHT shortly after the start, failed to factor. BENNY BEAR sent hard, vied briefly racing three wide to the quarter pole, was all done by mid stretch, used up. HART MOUNTAIN hustled and raced wide throughout, dropped off upper stretch, was being pulled up coming to the finish, vanned off.
