**Footnotes**

SO PROPER tracked a loose leader through the turn, bid four path upper stretch, drove clear the last sixteenth. FOREST WIRE slow early circled out to upper stretch, came on gamely late six wide. PETITE ROUGE was crowded at the break, tracked through the turn, bid mid track upper stretch, weakened. RHYTHM OF THE NITE saved ground, vied near the rail upper stretch then leveled off. FRIENDLY MISS off slowly stayed back through the turn, improved past weary rivals late. BURNING AMOR in tight at the break was rushed clear, hustled off through the turn, wilted in upper stretch. CHATTY CAT was always a step slow. STRIKE APPEAL failed to respond. JUSTIN A STORM veered in at the break, chased early then gave way upper stretch.
