Footnotes

GHOST TOWN KAT set a pressured pace from the start, dug in entering the stretch, battled in a five way duel running between rivals from mid stretch, drifted out a bit nearing the wire crowding foes, just held on being fully extended. PINCH OF JOY settled in the second flight, launched rally coming six wide into the lane, drew even mid stretch vying in a five way battle, was out nodded at the finish missing in a good effort. DAZZLE N THRILL tracked down the backside racing a little off the rail, bid in tandem past the quarter pole, bumped with LITTLE ZEE at the eighth pole, continued on racing four wide, was in tight late when GHOST TOWN CAT drifted out a bit, was outfinished late by top pair. ENGLISH TEACHER pressed the winner from the start racing along the rail, matched strides to deep stretch, yielded stubbornly in a hard effort. LITTLE ZEE settled nicely racing mid pack, rallied five wide entering the stretch, vied running between foes throughout the stretch run, bumped with DAZZLE N THRILL at the eighth pole, was squeezed and steadied briefly at the sixteenth pole losing momentum. I'LL FIND YOU lacked speed traveling towards the rear, swung eight wide top of the lane, improved placing but never menaced. RUNNING EAGLE unhurried early, rallied along the rail from mid turn, cut the corner top of the stretch, vied briefly hugging the rail in upper stretch, flattened out inside the furlong marker. VIVENDI'S VERDICT was forwardly placed early on, gave chase leaving the quarter pole, swung wide into the lane, came up empty in the drive. SPECIAL VICTORY was always outrun, never involved. LOST QUEEN chased to the half, stopped past the quarter pole finishing weary. A STEWARDS INQUIRY INTO THE STRETCH RUN RESULTED IN DAZZLE N THRILL BEING DISQUALIFIED FROM THIRD AND PLACED FIFTH FOR INTERFERENCE TO LITTLE ZEE IN MID STRETCH.
