NATIVE NIKO sent hard form the gate, battled in a three way duel down the backside and on to the quarter pole, finally shook free turning for home, drew off mid stretch to win convincingly being kept to task. LAILA'S CHOICE settled along the rail tracking a trio of duelers, asked top of the lane, moved into the place position giving chase, never threatened the winner while holding on to second place. CALL THE GUY unhurried early racing towards the rear, angled out five wide top of the lane, went by tiring rivals improving position. RED HOT HUMOR was hard used from the start, dueled running between foes to top of the lane, had enough by mid stretch and began to tire. RIVRAV broke alertly, moved up three wide early vying for the lead, raced abreast rivals on the bend matching strides to the quarter pole, could not keep pace in upper stretch, faded from the eighth pole. BITESALOT was a step slow into stride, quickly angled to the rail, saved ground throughout never factoring. SONG FOR NICOLE was in good tracking position racing four wide, asked mid turn, lacked response and gave way top of the lane finishing spent.
