Footnotes

UNCLE TOODIE well handled, was not far off the pace going down the backside, quickly bid five wide at the quarter pole, blew by the field top of the stretch, angled to the rail mid stretch, drew off and was in hand coming to the wire. QUESTIONABLE SKY settled towards the rear, gained momentum leaving the quarter pole, swung eighth wide top of the lane, received left handed stick in the drive, closed willingly to secure the place position. SEA HERO'S GHOST tracked the pace to the quarter pole, split foes upper stretch, gave hard pursuit running between foes, was out finished late losing the place position. FURIOUS CHAD sent hard, vied running four wide and between rivals on the bend, weakened inside the furlong marker, hard used. DARING HABIT rushed bid racing six wide at the quarter pole, held menacing position turning for home, flattened out mid stretch. GENTLEMEN'S CLUB settled in the second flight, angled out six wide upper stretch, failed to sustain rally, leveled off. DAKOTA FREEWAY was sent hard, set a pressured pace traveling between rivals, had enough by mid stretch giving way. NUMATTIC was outrun to the quarter pole, swung widest into the stretch, never factored. SON OF A LUE vied early in a hotly contested pace, gave way in upper stretch, used up. TRAVELEZE pressed briefly running along the rail, chased form mid turn, gave way entering the stretch, no threat.
