Footnotes

JACK O' LANTERN prompted the pace abreast LAY LINE FORCE through the turn, wrested a clear lead in upper stretch dropping down to the rail holding sway to wire. RUMMY'S COMMAND a step slow through the turn raced outside of rivals in the six path down the stretch surging late to salvage place. ENDOFCONVERSATION chased through the turn angling to the four path upper stretch, extending the final eighth finished well. ATTRACTIVE RIDE raced evenly through the turn, moved at mid track down the stretch giving belated response. LAY LINE FORCE breaking sharply pressured the pace through the turn ceding into upper stretch, angled off the rail weakening late. ROAR AS THE WYNND slow early circled out seven wide in upper stretch remaining no factor. TOWER OF LONDON a step off the early pace would fade on the turn. SNEAKIN THRU struggled throughout.
