Footnotes

DELAWARE TWITCH was hustled out working on a short lead through the turn, hooked from the outside by DRESS IN DUBAI in upper stretch would drift out crowding rival before going clear late. DRESS IN DUBAI bobbled leaving the gate, recovered quickly pressuring DELAWARE TWITCH to upper stretch, bearing down abreast rival was crowded as the leader drifted out steadying briefly late. RIVER BLADES stayed close threatening through the turn, extended inside the leaders in upper stretch would weaken in the three path. JONES TIME slow early improved a bit finishing evenly at mid track. AMERICAN ROMANCE lunged at the break stayed back through the turn saving ground to upper stretch proving no menace there. SAHMBLA LA VISTA raced second flight playing no factor. AUBERGE DE FLEUR gave steady retreat finishing up in the three path. An objection from the rider of DRESS IN DUBAI against the rider of DELAWARE TWITCH citing interference during the stretch run was disallowed by the stewards.
