**Footnotes**

SPECK OF PEACE rated near the early pace, traveled 5 wide to the 1/2 mile pole, kept there advancing into stretch, drew even abreast horses, had more drawing off late . LIVAE veered out leaving the gate, settled at the back, roused to move inside the 3/8 pole, circled 6 wide upper stretch, was all out to save place . DEVINE FAITH made a short lead into the opening turn, widened margin on slow splits down the backside, collared between horses inside the 1/4 pole, extended in drive, leg weary final 1/16 . SILENT REASON was hustled close up, went 4 wide into the backstretch, continued to pursue under urging into the final turn, began to weary down angling to the inside in upper stretch, had no impact late . SOUTHERN JEWEL away slowly, tucked inside while unhurried to the 1/2, gave a response advancing from the turn to mid stretch, swung off the inside and leveled off late . GABBY DANCER sent to contest the early pace, backed off a duel and tracked DEVINE FAITH to the 1/2 mile pole, closed in on rival nearing the 1/4 pole, had nothing left for the stretch drive and gave way . FANCY N' FIT lost ground while always outrun . GOLDEN DRAGON (FR) moved evenly in second flight, flattened out after a 1/2 mile . PEACE had brief foot, gave steady retreat near the rail .
