QUICK VERDICT unhurried early fired to bid from the quarter pole surging clear four deep into upper stretch continuing on full of run winning going away. PITY FIRES well rated responded on the far turn gaining six wide into upper stretch, drifting out a bit in drive went fully extended to save place. MISS DENIRO dropped back early trailing to the half, found stride out of the far turn giving strong action in drive at mid track. FOREVER GRACE sent clear set a moderate pace to the far turn, wavered near the three sixteenths pole giving way to upper stretch. ARBITRAGE played no factor. SHESCHOCOLATEFUDGE stalked the pace moving to leader on the far turn, weakened in upper stretch fading back in drive. MILL CREEK LADY raced evenly before tiring in upper stretch. B BLUE well placed stalked close up through the far turn, abruptly flattened out in upper stretch. WAY TOO TIPSY struggled throughout.
