SAPPHIRE HILL hustled off to set a well rated pace, traveled a little off the rail throughout, was never seriously challenged, asked for more turning for home, responded to increase advantage, kept to task to the finish. DONNAS TRIAL stalked the winner from the start, put to a drive mid turn, chased into the lane, never menaced, proved a game second best. IN FOCUS trailed soon after the start, lagged to the far turn, found stride near the quarter pole, angled top of the lane, closed willingly in deep stretch. GOLDTOGOWITH stalked the winner running towards the inside, asked mid turn, chased but failed to gain leaving the quarter pole, weakened mid stretch, bested rest. SOBER MOMENT raced mid pack and five wide at the half, made a mild bid at the quarter pole, leveled off in the drive. RUBY FIELDS lacked speed, raced well off the rail going down the backside, swung six wide into the stretch, mildly improved placing. OCCATILLA raced mid pack and between rivals to the half, urged far turn, lacked response, tired in the lane. KENTUCKY CAT hustled and gave a brief chase to the half, weakened mid turn, angled wide into the stretch, no factor. WILDABOUTAUNTY chased while between rivals to the half, faded leaving the quarter pole, all done by upper stretch.
