VALID VENTURE sent clear set the pace maintaining a short lead through the turn, angled from the two to the four path in mid stretch would draw off under urging. RAMBLIN MIKE stalked close up through the turn looming in the four path upper stretch, proving no match for the winner extended late saving place. PATROL LEADER away slowly trailed the field circling out leaving the turn, bid widest in the six path gaining position late. GOOD QUESTION chased the pace while saving ground, all out in the two path upper stretch would wear down the last eighth. SHOW ME THE CASH hustled along in mid pack weakened near mid track in upper stretch. BUCK CASH came in pinching DREAM NOW at the break, never reached contention. I'VEGOTTABEME came out pinching DREAM NOW at the break, failed to menace. K'S BOYWONDER gave hard pursuit laying close through the turn, faded along the inside in upper stretch. DREAM NOW pinched back at the break would labor.
