EMILY SUN SHINE broke alertly prompted the pace on a short lead through the far turn, digging in from the two path battled FILLAZZENE refusing to back down winning clear in the three path. FILLAZZENE hustled out would prompt the pace moving alongside EMILY SUE SHINE from the outset battling through the far turn into upper stretch, continuing to bear down there gave all in the four path to no avail. ASHBY LAND unhurried early rallied along the inside on the far turn, swung off the rail an eighth out finishing evenly in the four path. CUYAHOGA RIVER tracked the pace through the backside edging closer to threaten on the far turn, extending from mid track in upper stretch would wear down. DANCINGTHENITEAWAY slow early advanced to bid on the far turn then leveled off at mid track in upper stretch. MARIA'S MOON stalked along the inside through the backstretch then retreated on the far turn. NICOLE'S PASSION was never involved. SPLENDROUS hustled out would track the pace racing four wide to the half then wilt on the far turn.
