COUNTRY DIVA broke well, pressed for the lead down the backside, took over near the quarter pole, was confidently ridden receiving mild encouragement to draw off convincingly. FAST AND FLUID sent hard, set an early pressured pace, battled to top of the lane, was no match for the winner, received strong left handed stick to save the place position in game try. AFLEET ANGEL reserved early, hard ridden at the quarter pole rallying four wide, leveled off mid stretch, bested rest. A LITTLE WILD unhurried down the backstretch, roused angling six wide entering the lane, failed to menace. BALLAD OF BERTIE stalked running along the rail to the quarter pole, put to a drive angling wide entering the stretch, came up empty and never threatened. SPLENDID IN SPRING made a quick retreat to trail racing at mid track, put to a drive in upper stretch, failed to respond, no factor.
