FORMAL TESTIMONY laid close up stalking to upper stretch, extended up abreast foe in the two path. TEACHER BOYNE sent clear hustled a short lead through the turn, hooked inside down the stretch ceded grudgingly. CAST NO SHADOW raced a step slow through the turn, gave a mild rally in the three path upper stretch, held spot with even action. PAULNPAUL went evenly through the turn, came six wide upper stretch, lacked surge. ACCORDING TO MIKE slow early played no factor. DUKE SKYWALKER was never involved. FLASHY'S BRO was always outrun. ROAR TIGER ROAR dropped back early, failed to respond. OFFICER FRANK chased through the turn then gave way in upper stretch.
