Footnotes

SAY JAS rushed hard pressing for the lead, duelled inside of FOOLING PLEASURES from the start, slowly edged clear of that rival inside the sixteenth pole, won going away under strong handling. POOLING PLEASURES rushed hard soon after the start while angling towards the rail, could not clear and duelled racing outside the winner around the turn, was no mach losing ground inside the eighth pole, held well late easily proving second best. WITCH TOWN settled in good tracking position, bid between foes upper stretch, surged late gaining the show position. SNORKEL showed good speed vying briefly for the early lead, had to steady briefly going into the far turn when FOOLING PLEASURES angled towards the rail, stalked the top pair around the turn, chased under urging entering the stretch, lacked kick and was out finished vying for a minor award. THE RIDER OF SNORKEL CLAIMED FOUL AGAINST THE RIDER OF FOOLING PLEASURES FOR INTERFERANCE ENTERING THE FAR TURN, AFTER REVIEW, THIS CLAIM WAS DISMISSED. LOW COUNTRY GIRL settled in good tracking position, bid four wide giving chase near the quarter pole, leveled off mid stretch needing more. CATERINAMARIA flashed early foot, stalked racing between rivals around the bend, lacked response when asked for more, no threat in the stretch run. CHANGING YEARS lacked speed racing towards the rear, offered little. FERMEZ LA PORTE lacked speed running towards the rear, stopped mid stretch and was eased, walked off. TODAY'S QUICKIE moved to the rail shortly after the start, rushed hard going into the far turn and run up on the heels of DYNARAN, stumbled and rider lost irons, was immediately eased. DYNARAN flashed speed leaving the gate, was out sprinted for the lead, was bumped from behind by TODAY'S QUICKIE going into the far turn and hit the rail, was eased thereafter.
