CLARKSBURG EXPRESS broke well and tracked the pace to top of the lane, came five wide from upper stretch, blew by tiring duelers inside the eighth pole, won going away being ridden out. JETINA trailed to mid turn, found stride mid stretch, split foes late and surged traveling towards the inside at the wire getting up for second place in last jumps. BETH'S ANGEL settled in mid pack, rallied three wide from upper stretch, was out noddod missing second place in a willing effort. CONGRATS TO ME quickly showed in front and moved off to a clear lead around the turn, traveled in the three path turning for home, was hard ridden from mid stretch but faltered at the sixteenth pole finishing leg weary missing a minor award. REEL SPINNER stalked loose leader from the start, moved to mid track past the quarter pole, bid four wide upper stretch, loomed with a furlong to go, weakened late. VELVET DANCER well placed early on, gave chase entering the stretch, drifted inward at the sixteenth pole herding FASHIONABLE GIRL causing that rider to check, lacked needed rally. FASHIONABLE GIRL raced evenly in mid pack, traveled along the rail in the stretch, had to check and brushed the rail when VELVET DANCER drifted inward. FOLLOWING A STEWARDS INQUIRY INTO THE STRETCH RUN, VELVET DANCER WAS DISQUALIFIED AND PLACED SEVENTH FOR INTERFERENCE TO FASHIONABLE GIRL IN DEEP STRETCH. ABOVE GRADE raced evenly in the second flight, failed to respond despite being hard ridden. KENNIDY'S COURT was always outrun and raced very wide in upper stretch. PENNSYLVANIA PATTY raced evenly at mid track in the second flight, weakened from upper stretch.
