CONCORDE COUNTY opened up early, was rated entering the backside, dueled on the far turn, dug in gamely when asked and was all out to hold on. EDGE OF GLORY tracked inside, angled out at the top of the lane, rallied three wide and just missed. UNCLE HARRY raced three wide off the pace and rallied outside. TIGER EXPRESS had a three wide trip and rallied mildly outside. CANDY MINE raced four wide on the backside and rallied mildly between. UP MARKET raced between foes, saved ground on the far turn and failed to respond. MAD DANCER pressed the pace between rivals, dueled on the far turn and tired. ANDROMEDA'S STORM raced off the rail and faded.
