Footnotes

PENNIES APPEAL well placed and inside into the turn, raced between rivals passing the quarter pole while just off the inside then finished gamely to prevail. CAVIAR N CHAMPAGNE up close early outside, raced three wide on the turn and pressed the issue, drew clear in the stretch then continued on gamely to the wire. HOW SHE ROLLS lunged out at the start, chased and raced four wide passing the quarter pole then finished willingly while needing more. WEST COAST LADY saved ground into the turn, was just off the inside into the stretch then offered a late gain. CONCEPT broke through the gate, vied for the lead from the two path and weakened in the drive. ZERO YIELD near the rail on the turn, raced in the three path into the stretch and lacked a rally. LEGALIZED broke slowly, chased near the inside and lacked a stretch response. VIBRANT WORSHIP outside on the turn, raced five wide into the lane and tired. GOONSQUAD moved up inside early and vied for the lead then tired through the lane.
