

SILVER TIMBER saved ground into the turn, eased out and lodged a bid on the bend, raced four wide entering the stretch and came in slightly passing the furlong marker then finished well while drawing clear. TRUE TO TRADITION broke in some then up close along the inside, came out some for room nearing the eighth pole then finished gamely. BLUE SAILOR set the pace inside, held a clear edge in midstretch then weakened late. PERFECT OFFICER trailed to the lane, moved out for the drive and offered a late gain. HEROS REWARD saved ground into the lane, eased out in upper stretch and offered a mild late response. AFFIRMATIF prompted the issue from the outside, raced in tight passing the eighth pole and weakened. OUR FRIEND HARVEY chased and near the inside on the turn, raced in the three path entering the lane then was steadied and bumped passing the eighth pole losing position and was not persevered with thereafter. PILANESBERG raced three wide on the turn and weakened. The stewards posted the inquiry sign and the rider of OUR FRIEND HARVEY lodged a claim of foul against the winner alleging stretch interference but no change was made.
