WILDCAT BRIEF saved ground into the turn, moved between rivals on the bend and continued between foes to the lane, drifted in slightly nearing the eighth pole then finished well and drew clear late. TOULOUSE LAUTREC advanced three wide on the turn and reached the front approaching the quarter pole, drew clear then was no match late to the top one. SUBTITLES vied for the early lead, saved ground and weakened in the drive. EASY GALLOP vied for the early lead outside a rival, raced in the three path into the stretch and weakened. A claim of foul by the rider of SUBTITLES against the winner for interference on the turn was not allowed.
