Footnotes

DE CHERA was bumped at the start, dueled two wide for command, battled it out with VALENTINOS GOLD turning for home, dug in determinedly between rivals, bumped with LAMAR VALLEY late and was all out to prevail. LAMAR VALLEY was outrun early, moved up on the turn, came three wide between rivals into the stretch, rallied inside, bumped with the winner late and missed. BRIMSTONE AND FIRE raced five wide into the first turn, continued three wide off the pace, made a five wide run on the far turn and dug in outside to the finish. VALENTINOS GOLD raced four wide early, stalked outside a rival, bid three wide on the far turn and dueled between rivals to the finish. SOUTHSIDE CHARLIE raced off the pace, came four wide into the lane and closed belatedly outside. VIOLATOR failed to threaten. STONES THROW raced four wide into the clubhouse turn, angled over, chased inside and tired. Z FORCE was pinched back at the break and outrun. DANCE SAFELY chased three wide and faded. BURIEDBEYONDBELIEF bobbled at break, dueled inside and gave way. A Jockey's Objection by the runner up against the winner was dismissed.
