Footnotes

RICHIEFROMSHOPRITE set the pace on the inside, responded when asked and kicked clear in upper stretch, driving. HOP SKIP AND AWAY raced off the pace, advanced between rivals on the far turn and rallied on the rail for second. JAVERRRE raced between foes, saved ground on the far turn, drifted out in front of SILENT APPEAL near the furlong marker and then stayed on for third. FINE FRIENDS raced off the pace, moved up four wide on the far turn and gained mildly. CHILKOOT TRAIL was outrun early, moved up on the far turn, came wide and gained belatedly outside. CACAWAY raced off the pace, three wide into the lane and gained mildly inside. JERSEY BLUE GIANT raced off the pace, moved up four wide on the far turn, then five wide past the quarter pole and flattened out. FINAL FOREST was outrun early and bested the others. ARLO raced close up inside, chased on the rail and weakened. LOVE WHO chased three wide, bid four wide at the quarter pole and tired. SILENT APPEAL pressed the pace, weakened, then clipped heels and stumbled near the

eighth pole. CIRO'S CLEARANCE steadied at the start and was outrun. HERMOSILLO stalked three wide, raced between horses at the quarter pole and tired. FLIRTATIOUS SMILE did not factor. After a Stewards' Inquiry, JAVERRE was disqualified and placed eleventh for interference near the eighth pole.
