Footnotes

HOW SHE ROLLS three deep into the turn, reached the front on the bend outside a rival, dueled through the lane and edged clear late. LEGALIZED moved off the inside early, saved ground on the turn and battled for command then finished willingly while unable to match the top one late. WEST COAST LADY raced four wide on the turn and offered a late gain. DEMI TASSE four wide into the turn, chased and raced in the three path turning for home then weakened in the drive. PENNIES APPEAL raced in the three path into the lane and lacked the needed bid. SHEBOP was along the inside through the lane and lacked a bid. BRONXGIRL vied early between rivals and weakened on the turn.
