GOTTCHA GOLD drew clear on the clubhouse turn and widened on the backstretch, saved ground to the lane and continued with a clear advantage into midstretch then held off LAWYER RON nearing the wire while under vigorous hand urging. LAWYER RON unhurried into the backstretch, lodged a three wide bid on the final turn and was going well at the end. INDY WIND trailed while not far back, moved wide nearing the lane and lacked the needed rally. CHUCKER well placed early, was asked for run on the final turn, raced near the inside turning for home and tired in the drive. TAKE THE BLUFF tracked early, saved ground and weakened on the final turn.
