QUICK RIDE vied for the lead, saved ground into the far turn and responded to urging while edging away into midstretch then was ridden out. TISNOW JULIE up close and between rivals early, lodged a three wide bid on the final turn, chased and was second best. PONZI SCHEME up close early three wide, moved to the front between calls nearing the half mile pole, raced just off the inside turning for home and weakened in the drive. FULL LIQUIDITY vied for the early lead inside then settled up close, could not keep pace entering the far turn and moved four wide, came again some nearing the top of the lane then lacked the needed stretch response. BARELY NOTHING saved ground and lacked a rally. BID TIL INCLUDED raced near the inside into the far turn and lacked a bid. GOSMON trailed and outside into the far turn, lacked a rally.
