HEIR STREAM showed the way leaving the gate, was rated and raced between rivals while regaining the advantage on the turn then responded to urging during the stretch drive and edged away. DO SOMETHIN up close early outside foes, bid three deep on the turn and chased then was no match while second best. ANGEL DREAMS up close early three wide, raced just off the inside on the turn while behind rivals, swung four wide entering the lane and chased then was not good enough. PENNIES APPEAL raced in the four path entering the stretch and offered a late gain. NORTHWEST'S HOPE bobbled slightly at the start then moved up inside through the early stages to reach the front, saved ground and weakened in the drive. ALIRAVEN broke slowly, trailed and lacked a rally.
