### Footnotes

ESCROW KID saved ground and dueled for command, was just off the rail into the lane and edged clear in deep stretch then held to the wire. RAGING SIX saved ground turning for home, came out passing the eighth pole bothering rivals then finished gamely. SAFE TRIP dueled for lead outside a rival, battled into midstretch then weakened late. HOP SKIP AND AWAY raced just off the rail turning for home then was steadied when bothered a furlong out. GRAND SENSATION raced off the inside on the turn and chased then was bothered passing the furlong marker. TEMECULA CREEK never far back from the outside, was four wide into the lane and lacked the needed response while being bothered slightly a furlong out. The stewards posted the inquiry sign and also a pair of claims of foul were lodged which resulted in the disqualification of RAGING SIX from second to last for stretch interference with multiple rivals.
